They plan additional meetings that hopefully will be helpful to the Ag community and the Assessor's Office about current AG issues and how evaluations can be kept up to date.

i. The PG&E rate increase and the new power lines in the North County were discussed. Supervisor Rickman discussed the actions of the Board of Supervisors to oppose the proposed rate increases.
