Introduction and Methodology

As an integral part of learning residents within San Joaquin, CA County's perceptions and opinions regarding revisions within their congressional, senate, assembly, and supervisorial districts the County retained Critical Data Strategies LLC to develop and perform a county-wide online 'chat-type' survey.

The survey was performed **August 9 through August 15, 2021**. San Joaquin County publicized the survey via various marketing vehicles and utilized an email file containing more than 135,000 county resident email addresses. A link to the survey was embedded within the email and respondents accessed the survey via this link.

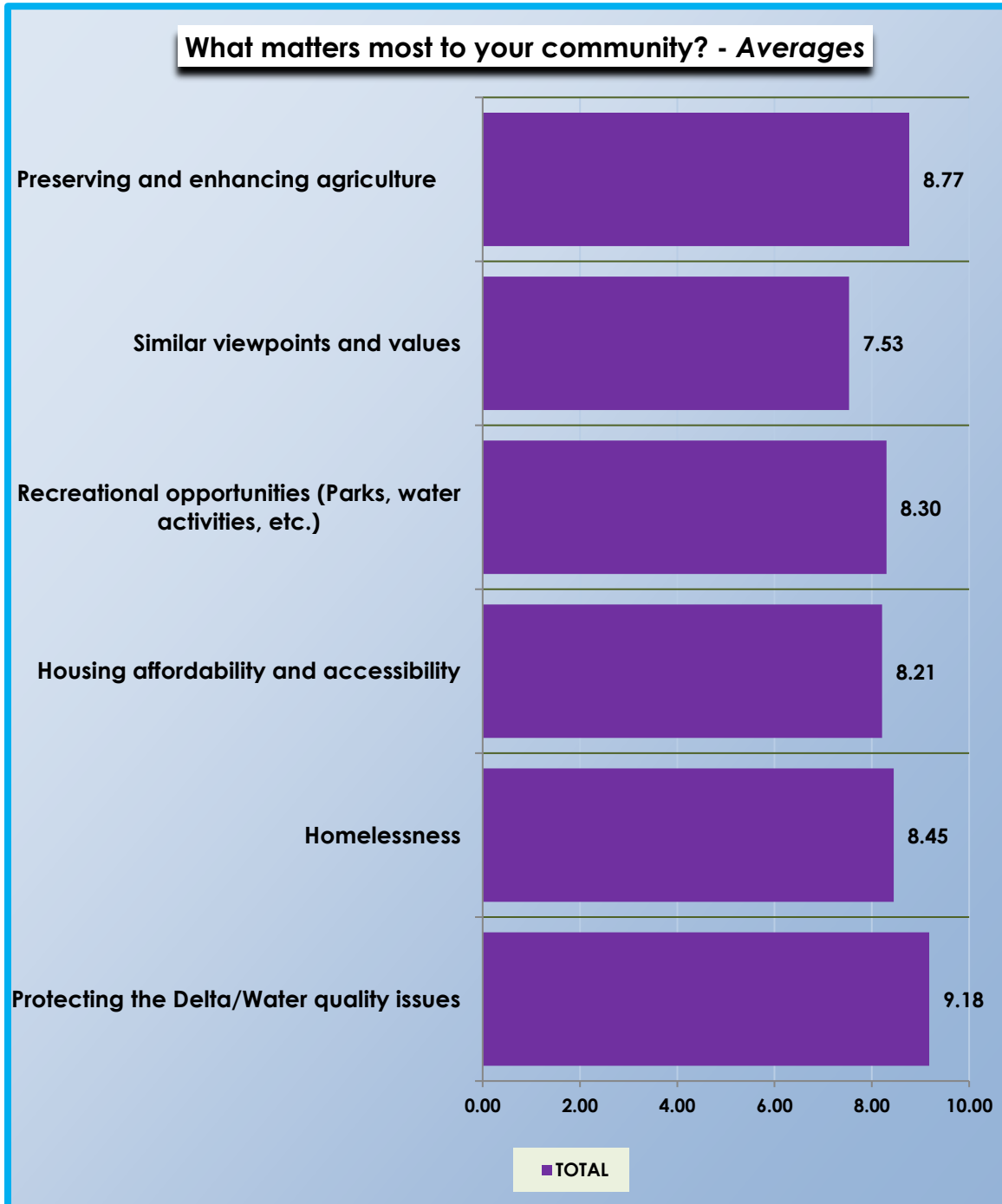
A total of **9,715** respondents accessed the survey initially, **8,773** individuals completed at least the first question, and a total of **7,511** respondents completed all survey questions. Because this survey was developed to gain input from as large a cross section of county residents as possible, a decision was made to retain every response even if a survey respondent did not complete the entire survey.

Survey participants responded from a variety of locations both inside and outside of San Joaquin County. Based upon examination of the IP address signing on to the survey, approximately 35% were completed by computers outside of the county. We believe that the most of these were due to persons employed outside of the county, residents on vacation, etc. Critical Data performed an analysis on responses provided by those in-county IP addresses and compared it with known outside of the county IP addresses and the difference in response to each question was, in most cases, less than 0.5%. No question or choice was different when comparing the two groups, thus this report contains the responses of the overall group as a whole, and our assumptions are that all outside IP addresses taking the time to complete the survey had a valid reason for doing so. The integrity of the survey was not compromised.



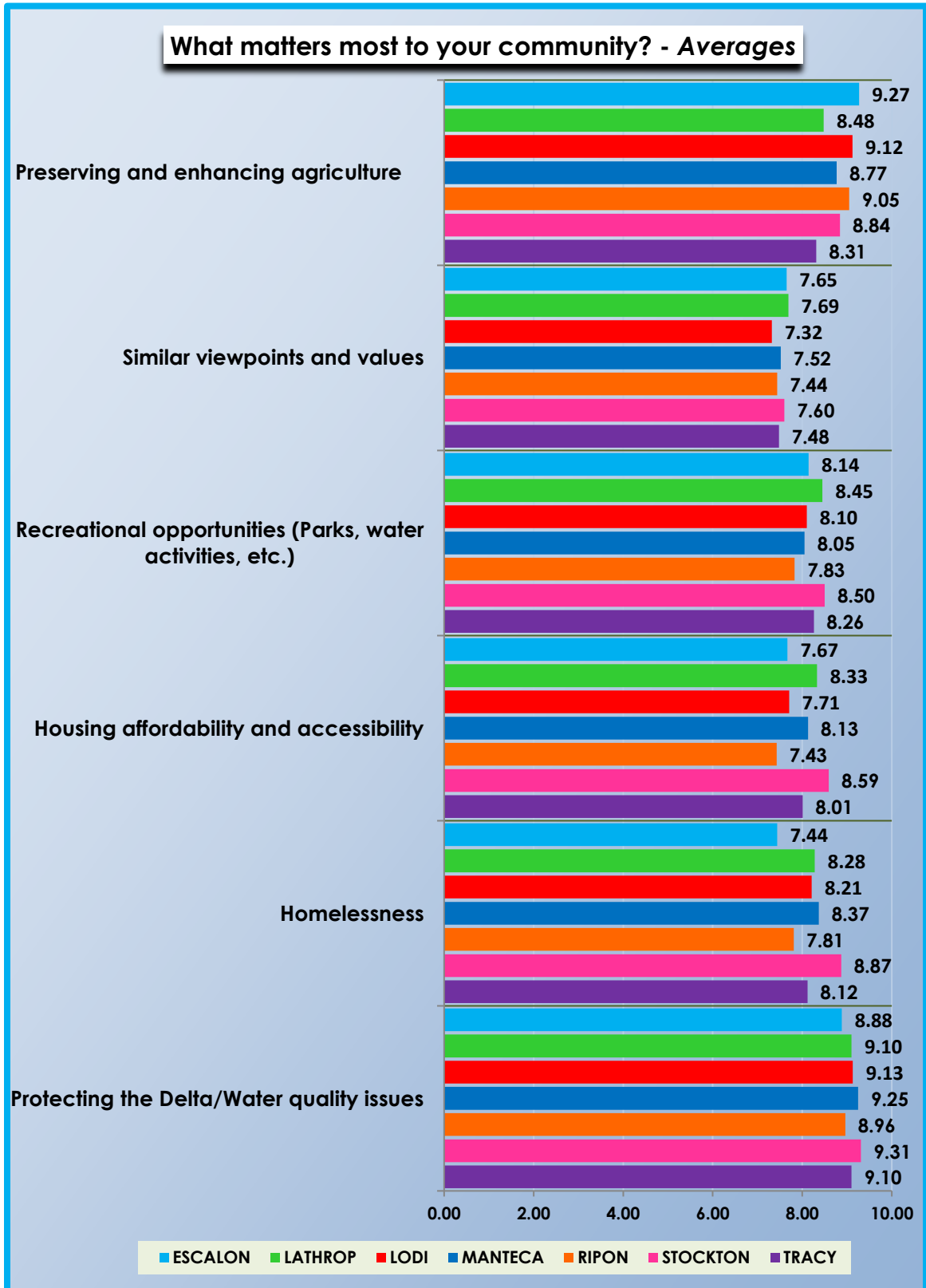

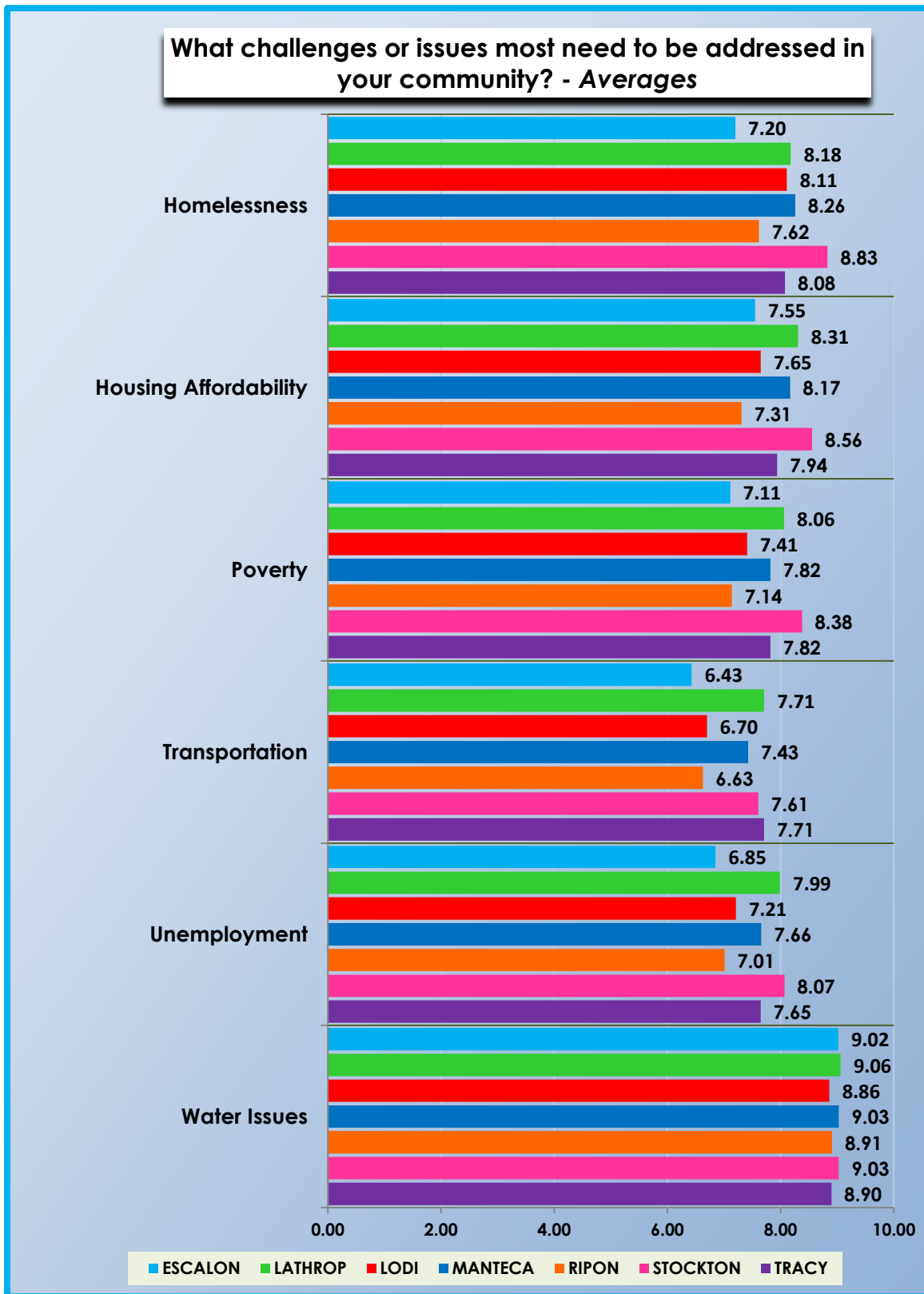

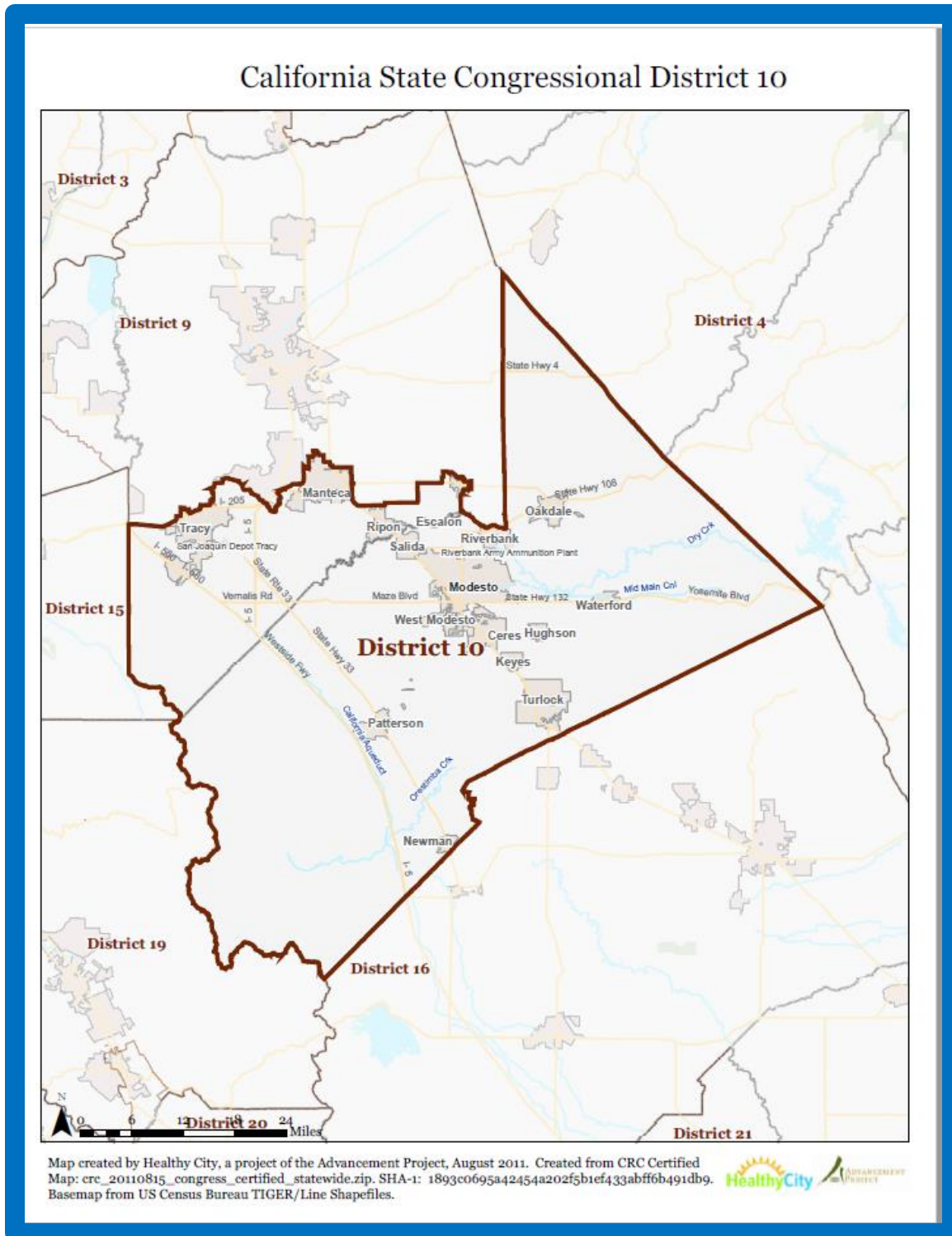

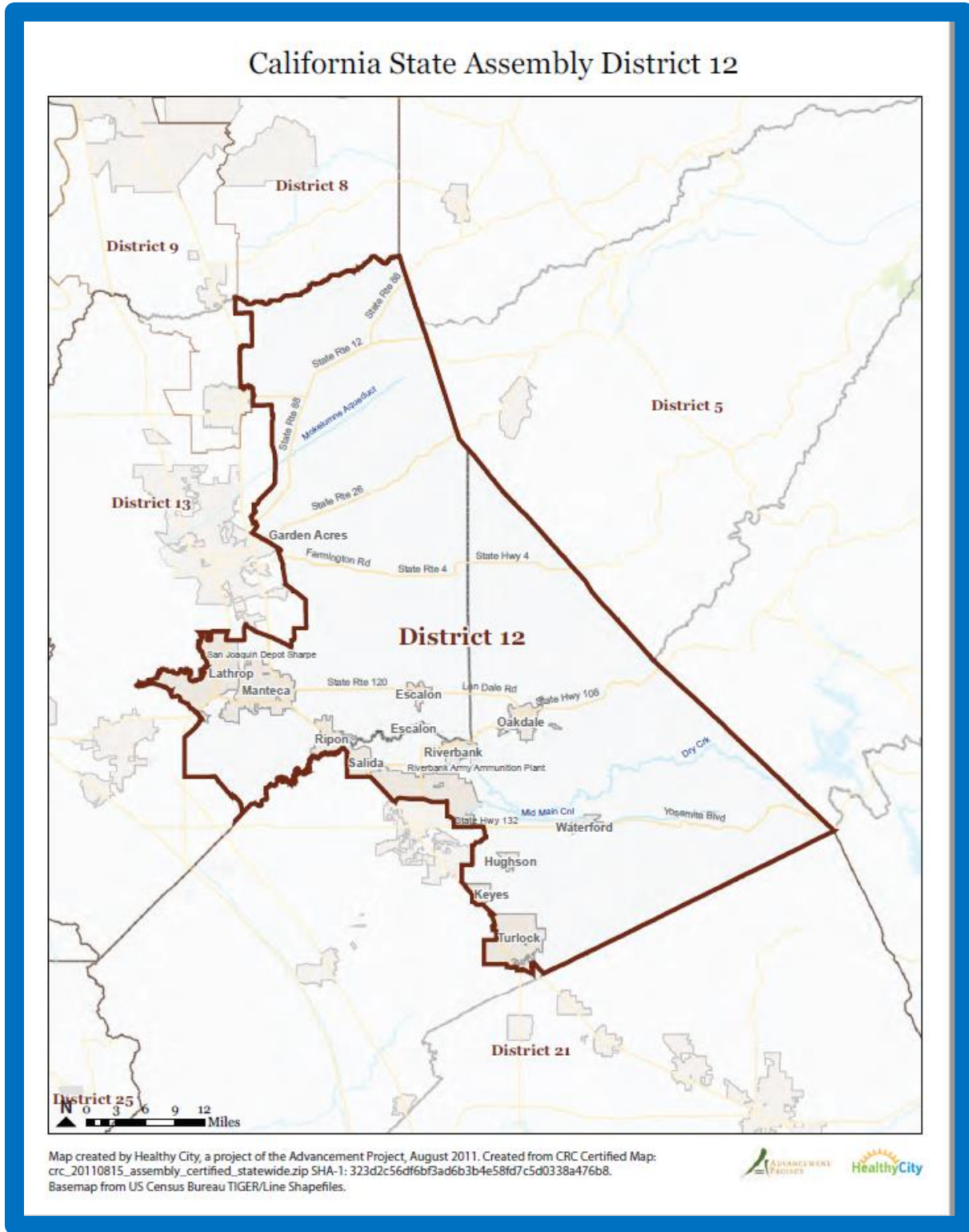

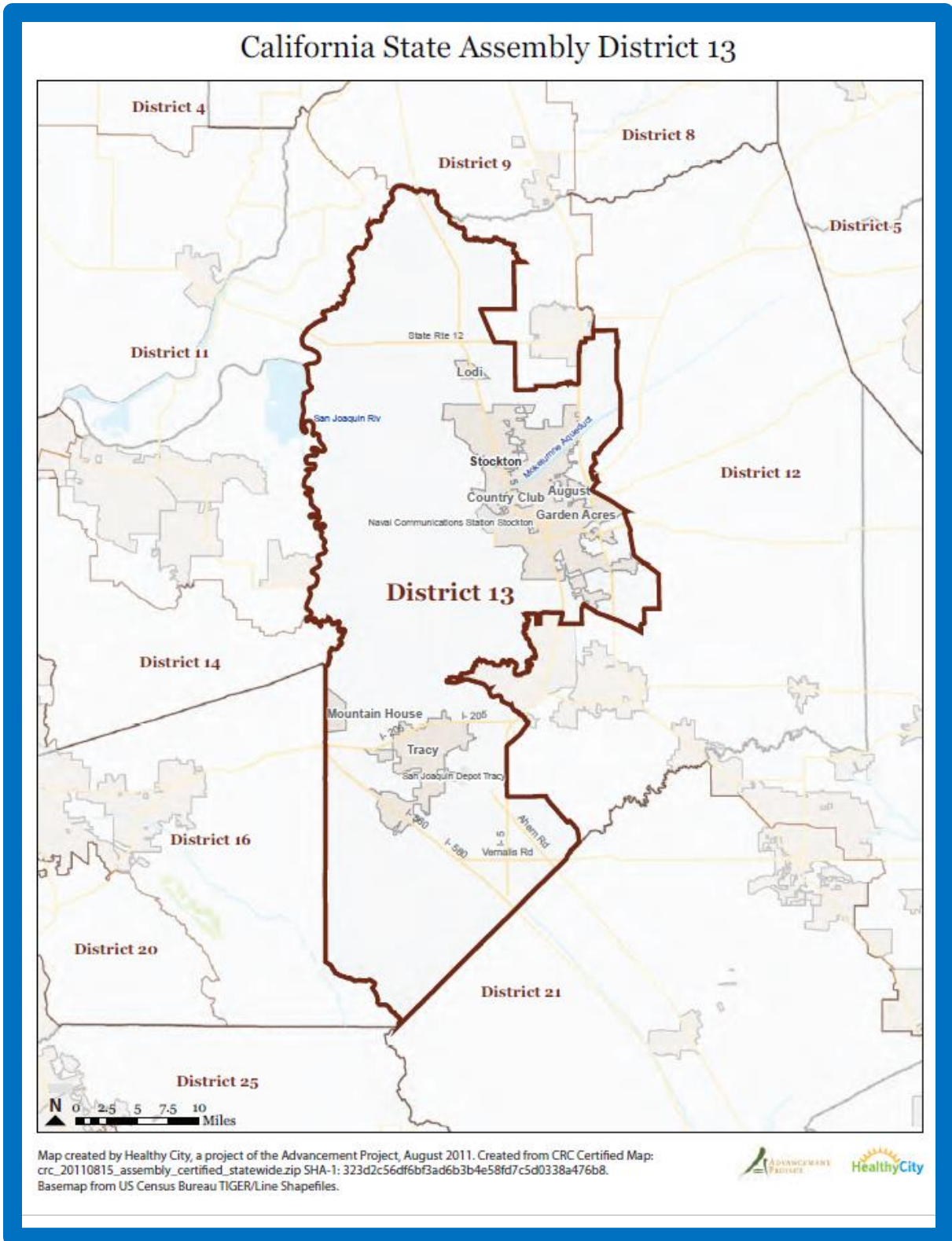
