4. Co-Applicant Agreement and Mou Between the County & SJ Health

Assistant County Administrator Brandi Hopkins informed the Committee that the County intends to start working with our partners at SJ Health, San Joaquin General and other affected departments on both the co-applicant agreement and the Memorandum of Understanding amendments in late August.

5. Present SJ Health Historical Financials and Quality Incentive Pool (QIP) Program Update

San Joaquin County Clinics (SJCC) CFO Kris Zuniga and Interim CEO of San Joaquin County Clinics (SJCC) Greg Diederich presented the history of SJ Health Historical Financials. District 2 Supervisor Paul Canepa had questions regarding the comparison between SJ Health, Community Medical Centers (CMC) and Golden Valley. Ms. Hopkins responded that this comparison will be presented to the Committee at the next meeting on October 16th.

Mr. Zuniga and Mr. Diederich provided the Committee with an update on the Quality Incentive Pool (QIP) program and responded to questions from the Committee. CEO of San Joaquin General Hospital (SJGH) Rick Castro recommended the SJGH and SJ Health Quality Team should collaborate prior to the June reporting deadline to work together to maximize funds.
