- a. <u>Paramedic Training Program</u>: Committee members were updated on progress of current NCTI/SJCEMSA paramedic class which began in March and ongoing work to partner with Delta college for a San Joaquin County program in 2025 and beyond.
- b. <u>Emergency Ambulance RFP</u>: Committee members were updated on the current and expected progress of the emergency ambulance RFP which is to take effect May 2026. SJCEMSA is currently working with the consultants developing the RFP based on the assessment findings that was published earlier this year. Expect submittal to EMSA for approval before the end of the year.
- c. <u>Med Net Radio Upgrade Project</u>: Committee members were presented with a report on the expected progress of the Med Net Radio system in San Joaquin County.

- a. <u>APOD Subcommittee Report:</u> Committee members were presented the ambulance patient offload data by hospital and providers for YTD 2024. Committee members were also provided a report on the subcommittee activities.
- b. <u>EMS Policies out for Stakeholder Comments</u>: Committee members were updated on the current policies out for stakeholder comments. Discussion on the EMS Maddy Funds approval process and qualifications for the Paramedic Preceptor Authorization policy.
