Please be advised that the San Joaquin County Environmental Health Department (EHD) received and approved a Report of Facility Information (RFI) amendment to the Solid Waste Facility Permit for Forward Resource Recovery Facility. The EHD is the Solid Waste Local Enforcement Agency (LEA) for this facility. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites in San Joaquin County.

### Description of Project and LEA's Determination

The Forward Resource and Recovery Facility is a permitted 33.23-acre existing transfer/processing facility and composting site located at 9999 S. Austin Road, Manteca. On October 30, 2024 the LEA received an application package proposing to amend the Report of Facility Information (RFI) as part of the Five Year Permit Review.

The amendment proposes to add the Short-Lived Climate Pollutant Reduction (SB-1383) organic materials required measurements and calculations, update the site layout details, update food waste processor details, and add physical contaminant measurement requirements for compost and green waste.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facility permit. The LEA approved the amendment on **November 18, 2023**.
