Please be advised that the San Joaquin County Environmental Health Department (EHD) received and approved a Report of Facility Information (RFI) amendment to the Solid Waste Facility Permit for the North County Sanitary Landfill & Recycling Center. The EHD is the Solid Waste Local Enforcement Agency (LEA) for this facility. The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites in San Joaquin County.

Description of Project and LEA's Determination

North County Sanitary Landfill & Recycling Center is a 320-acre existing solid waste facility located at 17720 E Harney Lane in unincorporated San Joaquin County, near the City of Lodi. On October 31, 2024 the LEA received an application package proposing to amend the Report of Facility Information (RFI) as part of the Five Year Permit Review.

The amendment proposes to add the Short-Lived Climate Pollutant Reduction (SB-1383) organic materials required measurements and calculations and update the site layout details.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA approved the amendment on **November 13, 2024**.
