(8)	A \$500 deposit is required for scope preparation on all Traffic Impact Studies. The deposit shall be applied towards the total cost of the study unless the study is not initiated by the applicant within 90 days, in which case a new \$500 deposit may be required to re-evaluate the scope.		
(9)	The total plan checking or field inspection fees for projects in this cost range shall be based on actual costs.		
(10)	A \$1,500 deposit is required along with the application for water from hydrants.		
(11)	Annexations to Special Districts will include other fee items (LAFCo processing, surveyor review, etc.)		
(12)	Meter test fees shall be refunded if the meter registers more than two percent fast.		
(13)	Utility service reconnection fees may be reduced subject to California Health and Safety Code, Division 104, Part 12, Chapter 6 for low income residents.		
(14)	A 20% technology surcharge fee will be applied to the final plan checking fee for projects with construction costs over \$500,000		
(15)	Plan checking fee increases are intended to cover the costs of implementing new electronic plan checking software. Use of the software is expected to result in development project cost savings by reducing printing / reproduction costs, reducing mailing costs and eliminating trips to/from the Public Works Department office during the plan checking process.
