Message From The Registrar of Voters' Office (ROV)

San Joaquin County experienced an enthusiastic voter turnout in the latest election, with 83,100 voters heading to the polls on Election Day. Overall, 267,627 ballots were cast, reflecting a 70.68% turnout rate.

In-person voting accounted for 48,900 ballots, including CVR (Conditional Voter Registration) and provisional ballots. Early voting saw 1,933 ballots cast, while a significant number of voters, 216,794, chose to vote by mail.

Of the vote-by-mail ballots, 105,194 were returned via U.S. mail, 76,722 through drop boxes, 678 directly to the Registrar of Voters (ROV) office, and 34,200 returned to polling locations on Election Day.

To ensure security, all 25 drop boxes across the county were equipped with live-streaming cameras, accessible to the public on the ROV website.

Additionally, sheriff escorts were provided for the final ballot pickups from drop boxes on Election Night and for transporting ballots from receiving centers to the ROV warehouse.

Throughout the process, all ballots were monitored under camera surveillance from the moment they arrived at the County Administration Building, including during opening, sorting, inspection, tabulation. scanning, and ensuring transparency and security every step of the way.
